Dear Mr. Adams:

Staff reviewed the application for amendment of certificate (application) submitted on April 21, 2016, on behalf of Commercial Utilities/ A Division of Grace & Company, Inc. (Utility). After reviewing this information we find the application to be deficient. The specific deficiencies are identified as:

1. **Current Land Use Designation.** Rule 25-30.036(2)(d)3., Florida Administrative Code (F.A.C.), requires that the applicant provide the current land use designation of the proposed service territory as described in the local comprehensive plan at the time the application is filed. If the proposed development will require a revision to the comprehensive plan, describe the steps taken and to be taken to facilitate those changes, including changes needed to address the proposed need for service. Please provide the current land use designation of the proposed service territory as described in the local comprehensive plan at the time the application was filed.
2. **Land Use Restrictions.** Rule 25-30.036(2)(d)4., F.A.C., requires that the applicant provide any known land use restrictions, such as environmental restrictions imposed by governmental authorities. Please provide any known land use restrictions, or a statement that there are none, if applicable.
3. **Department of Environmental Protection (DEP) Permits.** Rule 25-30.036(2)(j), F.A.C., requires the applicant to file a copy of all current permits issued by DEP. Please provide a copy of the Utility's current wastewater permit issued by DEP.
4. **DEP Reports.** Rule 25-30.036(2)(k), F.A.C., requires the applicant to file a copy of the most recent DEP and/or county health department compliance inspection report. Please provide a copy of the Utility's most recent DEP compliance inspection report.

5. **Correspondence.** Rule 25-30.036(2)(1), F.A.C., requires the applicant to file a copy of all correspondence with the DEP, county health department and water management district, including consent orders and warning letters, and the Utility's response to the same, for the past five years. Please provide a copy of the Utility's correspondence for the past five years, as required by Rule 25-30.036(2)(1), F.A.C., or a statement that there has been none.

As stated in my June 10, 2016, email, staff reviewed the Utility's amended notices filed on June 3, 2016. The amended notices are in compliance with Rule 25-30.030, F.A.C., and may be distributed as required by the rule.

Your application will not be deemed filed until the deficiencies identified in this letter have been corrected. These corrections should be submitted no later than July 11, 2016, to the following address:
