### Notice of Application for Amendment to Certificate Of Authorization to Extend Wastewater Service Area

Notice is hereby given this Aday of June, 2016, pursuant to Sect. 367.045(2), Florida Statutes, of the Application of Commercial Utilities, Inc., a division of Grace and Company, Inc., of its intent to apply to the Florida Public Service Commission for an extension of its service area to provide wastewater service to property in Jacksonville/Duval County, Florida. Commercial Utilities currently serves the Westside Plaza, Home Depot Plaza, and I-10 at Lane Avenue developments in the Duval County/Jacksonville Area.

Commercial Utilities has filed an application with the PSC entitled: Docket No. 16-0095-SU-Application for Amendment of Certificate No. 162-S to Extend Territory in Duval County by Commercial Utilities/ A Division of Grace & Company, Inc., to seek approval to serve the additional areas. Commercial Utilities is not requesting any changes or increases in its rates, classifications, charges, rules, or regulations in this application.
