2 **CHAIRMAN BROWN:** Okay. Moving to Item 5.

3 Good morning.

4 **MR. BARRETT:** Good morning, Commissioners.

5 **CHAIRMAN BROWN:** You're not Curtis.

6 **MR. BARRETT:** I am not Curtis. How is that?

7 Is that better?

8 I'm Michael Barrett from AFD staff.

9 Item 5 presents a joint motion from Florida Power &
10 Light and the Office of Public Counsel to resolve two
11 issues concerning replacement power costs for outage
12 events that occurred in 2014 and 2015 at FPL's St. Lucie
13 Unit 2 generating plant.

14 Staff believes the joint motion is a
15 comprehensive settlement that fairly and reasonably
16 balances various positions of the signatories. If the
17 joint motion is approved, these outage matters will not
18 be addressed in the November fuel hearing or in any
19 future event, and FPL will credit \$8 million to the fuel
20 cost recovery clause.

21 There have been no customer comments filed in
22 this docket, and representatives from FPL and OPC are
23 here to address you, if needed.

24 Staff recommends approval of the joint motion
25 and is available to answer your questions.

1 **CHAIRMAN BROWN:** Thank you, Mr. Barrett.

2 So, Commissioners, any questions?

3 Mr. Barrett, this essentially just gets rid of
4 Issues 3J and 30 in this year's fuel clause.

5 **MR. BARRETT:** That's correct. Although we
6 haven't formally had an issue ID conference, these were
7 matters that were unresolved but they were ripe for
8 coming to you in November.

9 **CHAIRMAN BROWN:** Thank you.

10 Commissioners, could I get a motion?

11 **COMMISSIONER GRAHAM:** Move staff.

12 **COMMISSIONER EDGAR:** Second.

13 **CHAIRMAN BROWN:** All those in favor, say aye.

14 (Vote taken.)

15 Okay. The motion passes. Thank you. Thank
16 you, Mr. Barrett.
