RULE NO.: RULE TITLE:

25-30.445: General Information and Instructions Required of Water and Wastewater Utilities in an Application for a Limited Proceeding

PURPOSE AND EFFECT: Rule 25-30.445 would be amended to require in an application for a limited proceeding that a water utility must provide copies of all customer complaints that it has received during the past five years regarding secondary water quality standards set by the Department of Environmental Protection, along with its most recent secondary water quality test results.

SUBJECT AREA TO BE ADDRESSED: Consideration of secondary water quality standards in limited proceedings.
