Duke customers have been notified, and a description of 4 their billing differences have been provided to the 5 customers. 6 7 The petitioners negotiated the proposed agreement for a term of 30 years. The petitioners have 8 9 not received any feedback from the affected two customers and expect the transfer to be completed within 12 months 10 of the effective date of the proposed agreement. 11 12 13 14 15
