Mr. Bostwick:

I believe that I have already responded to your question once (see below) but we will go over it again. Your payment was received on 8/24 at the post office and deposited into our bank account on 8/25. I felt for sure you would have a problem with this so I kept the envelope that your payment came in. It is stamped that it was in St. Petersburg on 8/20 - there was no chance at that point that your payment would reach us by 8/21 - YOUR DUE DATE. I can provide a copy of that should you find it necessary. I have tried over and over again to explain to you that all mail is routed through Tampa/St. Petersburg BEFORE it comes back to Eaton Park. I also offered the suggestion that you try not waiting until the last minute to mail your payment but I guess you didn't care for my suggestion. Again - your current balance is \$7.00. If you still can't understand what I'm telling you, please feel free to contact me again and I'll try to explain it for the 3rd time. Your looking to blame anyone but yourself - where the blame belongs. I can only post payments that I receive and not until. Your constant threats of reporting me to the PSC is really getting old. This is a very simple process - You use the water, we take a reading, send you and invoice and you pay it timely - what I really can't understand is why all of you want to make it difficult for yourselves.

## Mr. Bostwick:

When a customer is late paying their bill, I don't notify anyone other than the customer. Your payment was received on 8/25/16 and yes, you were assessed a late fee. Your current balance is \$7.00 and if you have a problem with that than you can email whomever you see fit. Have a nice day!
