Dear Commissioner Brown:

I reside in the Town of Indian River Shores and have been an electric customer against my will of the City of Vero Beach since 1981 or 35 years. The incredible gross incompetence evident in the City's electric operations all these years has been mind boggling.

Regretfully, the PSC created this unfortunate situation when they approved the Territorial Agreement over 28 years ago and haven't reviewed it in all that time. Living in Indian River Shores, I am forced to pay electric rates considerably in excess of what FPL would charge, experience poor service and have no access to FPL rebates for energy efficient appliances or smart meters which possibly could lower my electric bills.

As a captive customer of the City, I am lashed to having to buy electricity from an unregulated monopoly at rates 30% higher than FPL. The City then uses the excessive unregulated profits to subsidize its gross mismanagement of the City.

When the franchise agreement expires in November, the City will no longer have the consent of my Town to operate an unregulated monopoly within its municipal boundaries. My Town is asking your Commission to view this as a "changed legal circumstance" and to grant its request for a change in territorial boundaries. I im-

plore you and your commision to rule favorably on my Town's request. Thank you.
