With regards to GPC's responses to staff's Interrogatories Nos. 12, 24, 29 & 31 this request contains information relating to competitive interests. Therefore, staff recommends that the information included in Interrogatories Nos. 12, 24, 29 & 31 be deemed confidential pursuant to Section 366.093(3)(e), F.S.

With regards to GPC's responses to staffs Interrogatories Nos.13 and 14 these requests contain information relating to competitive interests and information concerning bids or contractual data. Therefore, staff recommends that the information included in Interrogatories No.13 and 14 be deemed confidential pursuant to Section 366.093(3)(d) and (e), F.S.

Therefore, staff recommends that GPC's request for confidentiality of certain information included in Document No. 07162-16 be approved.
