Dear Commissioners:

I am a resident of Indian River Shores and am asking that you rule in the favor of Indian River Shores request to change our territorial boundaries. This would enable all residents of IRS to be serviced by Florida Power & Light for their electrical needs. We feel the City of Vero Beach has taken advantage of those Shores customers who have been forced to use the City for its electric provider. For many years the City has been charging us for not only the cost of electricity but a surcharge to supplement their

general fund. Not being residents of Vero Beach, we have no say in this matter.

Our town's franchise agreement for the purchase of electricity from The City of Vero Beach has expired, and consequently Indian River Shores and FPL have given to the City of Vero Beach a very generous offer to let those residents in question leave the Vero Beach utility for FPL.

Since the City of Vero Beach operates an unregulated monopoly in our Town, we are asking the Public Service Commission to view this as a "changed legal circumstance" and grant **our** request for a change in territorial boundaries.
