CHAIRMAN BROWN: Item 14, which I believe has an oral modification that has been distributed.

MR. JOHNSON: Good morning, Commissioners. I am Charlie Johnson speaking on behalf of Commission staff today.

Item No. 14 addresses staff's recommendation for Phase II rates for Brevard Waterworks. Brevard Waterworks is a Class C utility providing water service to approximately 237 customers in Brevard County.

The Commission approved Phase I rates on July 14th, 2015. For Phase II rates, the utility was ordered to work with OPC in Brevard County to provide the Commission a long-term solution and options of how to best address issues regarding the water system and rates.

The issues in this case relate to the deterioration of the distribution system, excessive unaccounted for water, purchased water expense, and the appropriate cost that should be recovered through rates. Staff's recommendation outlines the options and efforts taken in regards to the water system, which includes a reduction in rates for Phase II.

As you noted, there is an approved oral modification in the docket file. There has been no

additional customer contact after OPC's meetings with 1 2 customers. The utility and OPC are present to answer any questions today, and staff is also prepared at this 3 4 time to answer any questions.
