Duke Energy Florida, LLC (“DEF”), pursuant to the Order Establishing Procedure in this proceeding, Order No. PSC-16-0102-PCO-EG dated March 11, 2016, Order Revising Hearing Dates, Order No. PSC-16-0265-PCO-PU dated July 12, 2016, and Second Order Revising Hearing Dates, Order No. PSC-16-0394-PCO-PU dated September 20, 2016, hereby submits its Prehearing Statement:

C. Statement of Basic Position

The Commission should determine that DEF has properly calculated its conservation cost recovery true-up and projection costs, and should approve the conservation cost recovery factors for the period January 2017 through December 2017 set forth in the testimony and exhibits of witness Lori J. Cross.

D. Issues and Positions

DEF's positions on the issues identified in this proceeding are as follows:

**Generic Conservation Cost Recovery Issues**

**ISSUE 1:** What are the final conservation cost recovery true-up amounts for the period January 2015 through December 2015?

**DEF:** \$2,974,726 adjusted net true up amount of over-recovery. (Cross)

**ISSUE 2:** What are the total conservation cost recovery amounts to be collected during the period January 2017 through December 2017?

**DEF:** \$109,080,615. (Cross)

**ISSUE 3:** What are the conservation cost recovery factors for the period January 2017 through December 2017?

**ISSUE 4:** What should be the effective date of the new conservation cost recovery factors for billing purposes?

**DEF:** The new factors should be effective beginning with the first billing cycle for January 2017, and thereafter through the last billing cycle for December 2017. The first billing cycle may start before January 2017, and the last billing cycle may end after December 31, 2017, so long as each customer is billed for twelve months regardless of when the factors became effective. (Cross)

#### **Tampa Electric Company**

**ISSUE 5:** What is the Contracted Credit Value for the GSLM-2 and GSLM-3 rate riders for Tampa Electric Company for the period January 2017 through December 2017?

**DEF:** No Position.

**ISSUE 6:** What are the residential Price Responsive Load Management (RSVP -1) rate tiers for Tampa Electric Company for the period January 2017 through December 2017?

**DEF:** No Position.

## Generic Issues

**ISSUE 7:** Should the Commission approve revised tariffs reflecting the energy conservation cost recovery amounts and establishing energy conservation cost recovery factors determined to be appropriate in this proceeding?

**DEF:** Yes. The Commission should approve revised tariffs reflecting the energy conservation cost recovery factors determined to be appropriate in this proceeding. The Commission should direct staff to verify that the revised tariffs are consistent with the Commission decision. (Cross)
