PGS CHANGE IN DEPRECIATION

The proposed changes in depreciation rates and recovery schedules indicate the following functional changes in annual depreciation (in dollars):

Distribution	(\$6,866,639)
Transportation Equipment	\$ 37,549
General Plant	<u>(\$ 16,475)</u>
Total Change	(\$6,845,565)

The following narratives and schedules summarize the changes in depreciation rate components, annual depreciation expense, and the adequacy of the reserve for each depreciable category of plant based on the Peoples Gas System, the industry's expectations and recent experience. The study is organized into functional groups. Distribution, Transportation Equipment and General Plant are organized by plant account or sub-account. The proposed depreciation rates are at the account or sub-account level for all functions.

PEOPLES GAS SYSTEM

There is one major proposed change since the last Peoples Gas System depreciation filing. That change is related to average service lives and net salvage. The Mains - Other Than Plastic account indicates an increase in the average service life from 40 years to 50 years and a reduction of negative net salvage from (60) to (50). This is attributed to the impact of the Cast Iron and Base Steel replacement program.

In the 2011 study, reserve surpluses and deficiencies were addressed by resetting the accounts to the theoretical reserve calculation. This was done to synchronize each account with the whole life to stabilize rate fluctuations. The 2011 study yielded a total company reserve deficiency of (\$16,713,508). This reserve deficiency was allocated between the mains and service lines accounts. The 2016 preliminary review yielded a total company reserve surplus of \$807,117 before changes in rate parameters. The company is proposing in this filing reserve transfers to again synchronize each account to its theoretical reserve calculation. The 2016 study now indicates a total company reserve surplus of \$48,964,893. This is the result of the rate parameter changes made to the Mains - Other Than Plastic account for average service life and negative net salvage. The company proposes that this account shall carry the entire reserve surplus.

The 2016 preliminary review, before rate parameter changes to the Mains - Other Than Plastic account, yielded a total company depreciation expense reduction of (\$1,836,442) primarily driven by the reduction of the 2011 depreciation expense increases designed to eliminate reserve deficiencies. With the rate parameter changes, the 2016 depreciation study yields a total company reduction in depreciation expense of (\$6,845,565).

DISTRIBUTION PLANT:

Account 37402 - Land Rights

There have been no changes that will impact this account. No change in depreciation rate is being requested.

Account 37500 - Structures & Improvements

There have been no changes that will impact this account. No change in depreciation rate is being requested.

Account 37600 - Mains, Other than Plastic

There are some major changes that will impact this account. The theoretical reserve deficiency of (\$7,085,793) in the 2011 study is now indicating a theoretical reserve surplus of \$48,964,893 in the 2016 study. This is the result of the following rate parameter changes: the previously approved average service life was 40 years and the proposed average service life is 50 years; the previously approved net salvage factor was negative (60) and the proposed net salvage factor is negative (50). The changes are attributed to the impact of the Cast Iron and Base Steel replacement program. The previously approved depreciation rate was 4.2% and the proposed depreciation rate is 2.6%. As a result, the annual change in depreciation expense is a reduction of (\$6,165,074).

Account 37602 - Mains, Plastic

There have been no major changes that will impact this account, other than the theoretical reserve deficiency of (\$3,916,387) in the 2011 study is now \$0 in the 2016 study. The previously approved depreciation rate was 3.1% and the proposed depreciation rate is 3.1%. As a result, there is no change in the annual depreciation expense.

Account 37800 - Measuring & Regulating Station Equipment General

There have been no major changes that will impact this account. The previously approved depreciation rate was 3.4% and the proposed depreciation rate is 3.3%. As a result, the annual change in depreciation expense is a reduction of (\$12,925).
