CHAIRMAN BROWN: Moving on to Item 9. Good morning.

MS. OLLILA: Good morning, Commissioners. Ollila for staff.

Item 9 is Peoples Gas System's amended petition for approval of tariff modifications to rider NCTS, the firm delivery and operational balancing agreement and the negative imbalance cash-out prices. Two pool managers provided comments concerning Peoples' original petition. Subsequently, a noticed informal meeting was held with representatives from Peoples' staff, the Office of Public Counsel, and pool managers. The amended petition was filed in response to the discussion at the informal meeting.

The proposed modifications in the amended petition include requiring pool managers to pay their portion of the cost of peaking and future growth of streamed capacity. Also included is an increase in the prices paid by pool managers when their customer pool consumes more gas than is scheduled to be delivered by the pool manager, and the proposed modifications allow pool managers to increase the quantity of upstream capacity released during the month.
