Request for Confidential Classification for Docket No. 08629-16

On November 2, 2016, Ni Florida, LLC (Ni or Utility) filed its request for confidential classification for Document No. 08629-16. The document is part of Ni's response to staff's informal inquiry on allocated officer salaries in connection with the above-referenced docket. Certain information produced in response to staff's informal inquiry consists of a parent company employee name and total compensation. The Utility claims the information is intended to be, and is treated by, Ni as private and confidential, has not been disclosed externally, and has been strictly controlled internally. Staff has reviewed the document and concurs with the Utility that the nature of the information meets the requirements set forth in Section 367.156, Florida Statutes, whereby disclosure of the information would harm Ni's competitive business interests and would impair the ability of the Utility to contract for employees on favorable terms. Therefore, staff recommends that Ni's request for confidential classification of Document No. 08629-16 be approved.
