5	replacement surcharges for 2017. Staff notes that
6	at the agenda conference for last year's
7	proceeding, the Office of Public Counsel requested
8	an audit of the program. Staff worked with OPC on
9	the audit objectives. There were no exceptions
10	noted in the audit report.
11	For 2017, the proposed surcharge for
12	residential customer is 2.3 cents per therm. This
13	results in a monthly surcharge of 46 cents for
14	customers who use 20 therms a month.
15	There have been no customer contact. And
16	staff recommends approval.
