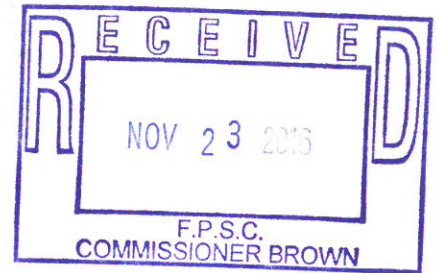

Dear Chairman and Commissioners:

You're probably going to just go ahead and rubber stamp all or most of whatever FPL wants, but before you vote, I'd like to remind you what the average Floridian thinks about FPL's rate increase request. I believe that most Floridians don't want and can't afford an FPL rate increase.

Enclosed please find a petition asking you not to allow FPL to increase their rates. There are 227 signatures. Eighty-four people signed the petition online. The other 143 signatures were obtained in person, in about three hours' time. The online petition offered an opportunity to write a comment, and many people did. Please read them. For your convenience, here are a few of them:

"I KEEP MY AIRCONDITIONING ON 85 NOW TO MANAGE YOUR ELECTRIC COSTS AND NOW YOU WANT MORE? WE ARE INDEED HEADING TOWARDS BEING A THIRD WORLD COUNTRY."

"Customers are paying enough and in no way does FPL need an increase. We are being gouged enough as it is."

"For a company that PROMISED cheaper rates with SmartMeters, what is this? Come on FPL, stop raising our rates and (worse) treating us like simple minded people who cannot possibly understand that FPL makes the max profit allowed by PSC"

"Why isn't 9% return on investment enough. It's huge compared to what most of us are getting on our savings and we are not getting any raises!"

"Enough is enough!! Over 22% increase is insane..who gets that kind of increase. Certainly not those of us on Social Security!!"

Please vote NO on allowing FPL a rate increase. Thank you for your time and consideration.
