Gulf Power Company ("Gulf Power," "Gulf," or the "Company"), hereby serves notice that it withdraws its Request for Extended Confidential Classification for certain information produced by Gulf Power in connection with the Commission's Review of Coal Combustion Residual Storage and Disposal Processes of the Florida Electric Industry (PA-10-10-004) (Document No. 08508-16). In support, Gulf states as follows:

1. On October 27, 2016, Gulf filed its Request for Extended Confidential Classification for certain information produced by Gulf Power in connection with the Commission's Review of Coal Combustion Residual Storage and Disposal Processes of the Florida Electric Industry (PA-10-10-004). *See*, Document No. 08508-16.
2. Gulf's Request for Extended Confidential Classification pertained to certain information contained within Document No. 02165-15.
3. On January 24, 2017, by letter to Gulf's counsel, the Commission Clerk returned confidential Document No. 02165-15 to Gulf. *See*, Document No. 00811-17
4. Accordingly, Gulf hereby withdraws its Request for Extended Confidential Classification identified as Document No. 08508-16.
