Description of Planned Network Changes:

BellSouth Telecommunications LLC d/b/a AT&T Florida, is providing notice that a Fiber in the Loop (FITL) architectural platform is being retired in the following Wire Center(s): Melbourne, FL (**MLBRFLMA**) (728 Palmetto Ave. Melbourne FL, 32901). AT&T Florida has deployed a Gigabit Passive Optical Network (GPON)/Fiber to the Premises (FTTP) platform serving the addresses listed below. This action will require the retirement of copper service wires (drops) and copper Network Terminating Wire (NTW) which are sub-loops per the FCC rule CFR §51.319(b). This project will not be implemented prior to 3rd Quarter, 2017.

Description of Reasonably Foreseeable Impact of the Planned Changes:

After the retirement of the FITL facilities, AT&T Florida will: (1) no longer offer services over the FITL facilities; and (2) cease maintaining the FITL facilities. Since the FITL platform is a fiber based architecture the only copper being removed is the copper service wires (drops) and any NTW replaced with new fiber NTW to NID or terminal. **There are no working customers on the facilities being retired under this notice.** The addresses listed below are impacted by this retirement.
