### FLORIDA POWER & LIGHT COMPANY'S NOTICE OF SUPPLEMENTAL FILING OF TARIFF SHEETS 8.030.1, 8.040, AND 8.042

Florida Power & Light Company ("FPL"), through undersigned counsel and pursuant to Sections 366.04, 366.05 and 366.06, Florida Statutes, and Rule 25-6.033, Florida Administrative Code, hereby files as Attached Exhibit "G" the following supplemental tariff sheets in legislative and clean formats to be included with the LT-1 proposed Streetlight tariff. The supplemental tariff sheets listed below were inadvertently not included when FPL filed the Petition for Approval of a New Pilot Light Emitting Diode (LED) tariff on December 16, 2016. The sole change on the supplemental tariff sheets is to add the "LT-1" tariff designation to the Twenty-Third Revised Sheet No. 8.030.1 "Billing Adjustments" Sheet, the Thirty-Sixth Revised Sheet No. 8.040 "Storm Charge", and the First Revised Sheet No. 8.042 "2017 Interim Storm Restoration Recovery Charge". This change has no substantive impact on the tariff sheets or on FPL's request for approval of the proposed new optional LED Streetlight Tariff.
