RESOLUTION NO. R-68-17

RESOLUTION URGING THE FLORIDA LEGISLATURE TO ENACT LEGISLATION TO CONTAIN ELECTRIC UTILITY RATES IN FLORIDA; AND URGING THE FLORIDA PUBLIC SERVICE COMMISSION TO PROMULGATE REGULATIONS TO CONTAIN SUCH RATES AND TO DENY THE CURRENTLY PROPOSED RATE INCREASE BY FLORIDA POWER & LIGHT

WHEREAS, in Resolution No. R-322-16, this Board opposed the rate increase proposed by Florida Power & Light (FPL) in early 2016 because of its potentially adverse impact on certain sectors of the population, particularly on those elderly residents and others who rely on fixed incomes to pay for their daily needs; and

WHEREAS, in November 2016, the Florida Public Service Commission (PSC) approved that rate increase requested by FPL; and

WHEREAS, that rate increase will allow FPL to collect from customers an additional \$400 million in 2017, followed by an additional \$211 million in 2018, and another \$200 million in June 2019; and

WHEREAS, with the first increase taking effect this month, a typical customer's bill is expected to increase by approximately \$7 per month, from about \$91.56 currently to \$98.77, with further increases to \$102.50 in January 2018, and then to \$103.70 in June 2019; and

WHEREAS, just two months after obtaining approval of the aforementioned rate increase, FPL filed another request with the PSC seeking an additional rate increase of \$318.5 million, this time to recoup its costs from responding to Hurricane Matthew and to replenish storm reserves; and

WHEREAS, this additional rate increase, if approved, would begin to take effect in March 2017, with a typical customer seeing an additional \$3.36 increase per month; and

WHEREAS, rather than shouldering FPL's customers with yet another rate increase, such costs should instead be borne by FPL's shareholders; and

WHEREAS, as noted above, this Board opposed, in Resolution No. R-322-16, FPL's 2016 rate increase request; and

WHEREAS, in Resolution No. R-502-16, this Board also opposed any electricity rate increase or special assessment proposed by FPL to pay the costs of remediating the environmental impacts of the Turkey Point Power Plant; and

WHEREAS, to limit additional rate increases, the Florida Legislature should enact legislation to contain electric utility rates in the state; and

WHEREAS, in addition, the PSC should promulgate regulations to contain such rates and should deny the currently proposed rate increase request by FPL,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges the Florida Legislature to enact legislation to contain electric utility rates in Florida.

Section 2. Urges the Florida Public Service Commission to promulgate regulations to contain such rates, and to deny the currently proposed rate increase by Florida Power & Light (FPL).

Section 3. Directs the Clerk of the Board to transmit certified copies of this resolution to the Governor, the Senate President, the House Speaker, the Chair and Members of the Miami-Dade State Legislative Delegation, and the Chair and Members of the Florida Public Service Commission.

Section 4. Directs the County's state lobbyists to advocate for the legislation and administrative action described in Sections 1 and 2 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2017 State Legislature Package to include this item.

The Prime Sponsor of the foregoing resolution is Commissioner Rebeca Sosa. It was offered by Commissioner Rebeca Sosa , who moved its adoption. The motion was seconded by Commissioner Sally A. Heyman and upon being put to a vote, the vote was as follows:
