Item 7 is staff's recommendation to approve the seat belt enforcement -- oh, sorry, not that -- approve the original certificates of South Sumter Utility Company, LLC, for water and wastewater service in Sumter County. The utility requested that this original certification process be split or bifurcated into certification now and rate setting later, in the third quarter of 2017.

To support this, the utility requested a waiver of Rules 25-30.033(1)(p) and (q). Staff recommends that the rule waiver be approved, and the utility should be granted its original water and wastewater certificates so that it may proceed with other permitting requirements. And staff is available to answer any questions you may have.
