AGREEMENT TO PROVIDE TELECOMMUNICATIONS RELAY SERVICE (TRS) TO FLORIDA

Second Amendment to Agreement

Pursuant to Section A.24 of the Request for Proposals (RFP) the Florida Public Service Commission (Commission) and Sprint Communications Company L.P., (Sprint), amend the Agreement to Provide Telecommunications Relay Service (TRS) to Florida as previously amended on January 6, 2015 (Agreement).

Sprint and the Commission agree to amend the Agreement as follows:

Section C6. of the Commission's RFP states, "If the bidder proposes to use subcontractors, the bidder shall identify those subcontractors and indicate the scope of their role in the provision of relay service." The "Subcontractor" definition in Section 1 entitled "Definitions" of the Agreement identifies "Caption Colorado" as a subcontractor under the Agreement and Sprint's Response to the RFP, "Item 72. Subcontractors," which is incorporated by reference into the Agreement, states that "Caption Colorado" is the subcontractor for "RCC technology and operations." The Commission and Sprint hereby amend the Agreement to provide that "VITAC" is the subcontractor which will continue to provide Relay Conference Captioning services in accordance with the Agreement. The Commission acknowledges that VITAC is the subcontractor providing Relay Conference Captioning services pursuant to the Agreement.

This Amendment makes only the stated changes to the Agreement. Except as stated herein no other change is made. Except as set forth in this Amendment, all other terms and conditions of the Agreement are unaffected and shall continue in full force and effect in accordance with the terms of the Agreement.

The Commission and Sprint acknowledge that this Amendment is a public record, is available to the public for inspection, and may be posted on a web site by the State of Florida.




