To Whom It May Concern:

Orange Blossom Utilities, Inc. (Orange Blossom) submits its application for approval of new class of service for private fire protection service in Sumter County. Pursuant to Chapter 367.091, Florida Statutes, and Rules 25-30.135 and 25-30.465, Florida Administrative Code (FAC), Orange Blossom requests the Florida Public Service Commission (FPSC) to authorize the Applicant to establish a new class of service and approve its Private Fire Protection Service Tariff.

In support of its request, the Applicant submits the following:

(1) The exact name of the Applicant and the address of its principal business office is:

(2) The Authorized Representative of the Applicant in respect to this application is:

(3) Orange Blossom currently provides Private Fire Protection (PFP) to two existing customers for no compensation. The two current PFP customers are being served through a 4" line and 6" line. These two customers are also currently being provided potable water service and wastewater service. In addition, Orange Blossom has recently been contacted by a developer who is moving forward with development of an additional General Service building which will also require PFP at its location.

- (4) Currently, Orange Blossom does not have an applicable private fire protection charge.
- (5) Rule 25-30.465, FAC provides for a "default" private fire protection service rate of 1/12<sup>th</sup> of the current base facility charge, unless the utility justifies a different rate.
- (6) In addition, Orange Blossom has simultaneously filed for a 2016 Index Application. Orange Blossom calculated its proposed PFP rates based on the 2016 Indexed base facility charges and respectfully requests that these two requests be reviewed and approved simultaneously.
- (7) Orange Blossom proposes rates consistent with the charge authorized in Rule 25-30.465, FAC and the attached proposed Original Sheet No. 13.1.
- (8) Currently, no new private fire protection customer is being charged a PFP rate for these services. Orange Blossom proposes to initiate this charge once it is approved by the FPSC and the customers receive the appropriate notice as required by rule.
- (9) Wherefore, Orange Blossom requests that the FPSC approve the requested new class of service for private fire protection and approve the attached proposed tariff sheet implementing the new rate.
