On July 7, 2016, I sent you a letter requesting assistance in obtaining information from Utilities, Inc and its subsidiaries regarding its assets. Then on September 6, 2016, I sent a follow-up letter because I had not received the information requested in my first letter. I have enclosed copies of both letters for your convenience. Six months has passed and I still have not received any of the information I requested.

Firstly, I asked for the net book value of assets for each system in Pasco County at the time of acquisition by Utilities, Inc. and its subsidiaries,

Secondly, I asked that each investment by UI/UI subsidiaries in systems located in Pasco County each year after acquisition, be identified, specifically identifying (a) assets acquired or constructed, (b) cost of each asset, and (c) reason for such investment.

Thirdly, I asked for them to identify the net book value of assets for each system in Pasco County for each year after the original net book value identified in the response to No. 1, above.

The people of Summertree are entitled to this information and, again, I ask for your assistance having UI/UI subsidiaries make it available.

I appreciate your assistance in this matter and look forward to your reply.

1. Net book value of assets for each system in Pasco County at time of acquisition by UI/UI subsidiaries.
2. Identify each investment by UI/UI subsidiaries in systems located in Pasco County each year after acquisition, specifically, identifying (a) assets acquired or constructed, (b) cost of each asset, and (c) reason for such investment.
3. Identify net book value of assets for each system in Pasco County for each year after original net book value identified in response to No. 1 above.

We continue to believe that UI investments in Pasco County systems don't justify the high rates being charged.

Thank you for your continued interest in the Public Service.
