IN THE FLORIDA PUBLIC SERVICE COMMISSION

Appellant, Sierra Club, amends its Directions to the Clerk filed on January 27, 2017, as follows:

- 1. In the above-captioned case, Appellant appealed Commission Order No. PSC-16-0560-AS-EI. This final order authorized Florida Power & Light Company ("FPL") to increase its rates and charge its customers for the billion-dollar expansion of certain fossil fuel-burning power plants, which the Commission has never determined to be the prudent, least-cost option to serve customers. Here, Appellant's appeal focuses on the Commission's acts and omissions with respect to that authorization, and not the other, disparate issues raised in consolidated Docket Nos. 160021-EI, 160061-EI; 160062-EI; and 160088-EI.
- 2. On March 8, 2017, FPL moved to strike from the record seven items identified in Appellant's Directions to the Clerk. As stated in Appellant's response,

the seven items should all be included in the record, and are all subject to judicial notice by the Florida Supreme Court. Nonetheless, to conserve judicial resources, Appellant hereby withdraws the seven items, listed in "Table 1" below, from its original directions.
