ON STATUS OF TERRITORIAL AGREEMENT BETWEEN
TAMPA ELECTRIC COMPANY AND SUMTER ELECTRIC COOPERATIVE, INC.

In Order No. PSC-94-1397-FOF-EU issued on November 16, 1994 in Docket No. 940947-EU the Commission approved the territorial agreement entered into by and between Tampa Electric Company and Sumter Electric Cooperative, Inc. Section 4.1 of said Agreement calls for an annual report from Sumter Electric Cooperative, Inc. providing the status of the Agreement and any modifications proposed in the Agreement.
