The following was submitted to WINK ACTION NEWS;

W have contacted the office of the Governor, Tyler L. Andrew, Office of Citizen Services, 850-413-6100, and directed us to the Florida Public Service Commission. Since the beginning of the year correspondence has gone back and forth with the following PSC officers, Bev DeMello, Assistant Director and Randy Roland, Regulatory Program Administrator. We have also contacted Mr. Bill Truex, Charlotte County Board of Commissioners who's office has been very helpful. The ownership structure of Utilities Inc (UIF) which has been impacting our water rates is as follows; BRITISH COLUMBIA INVESTMENT MANAGEMENT CORPORATION OWNS>CORIX>CORIX OWNS UTILITIES INC OF ILLIONOIS>UTILITIES INC OF ILLIONOIS OWNS UTILITES INC OF FLORIDA and is our provider. UIF is charging 3X's the amount that Charlotte County charges for water. We pay Charlotte County for property taxes, water usage and cannot use Charlotte County for wastewater usage. We are held hostage by UIF and this scenario is likely to continue if nothing is done. The Office of the Governor and the PSC pass the buck around. UIF to my knowledge owns no meters and relies on Charlotte County to supply the gallons used each month and then charges 3X's the amount for the same usage. Why not some transparency and why does UIF have a monopoly and hold it's users hostage. Hoping you can help in this matter.
