Interested persons receive all notices for hearing, prehearing, proposed agency action orders, final orders, and notices of Commission conferences via e-mail. If you are interested in receiving documents other than those mentioned above, for example, procedural orders, you will need to contact staff counsel for instructions on becoming a party of record for those specific dockets.
