Thank you for your April 21, 2017, letter to Chairman Julie Brown and Director Mary Yeargan. Because there is an ongoing rate case docket involving Utilities, Inc. of Florida, which includes the Summertree system, the Chairman's office asked me to respond. Section 350.041(2)(f), Florida Statutes, prohibits Florida Public Service Commissioners from making any public comments related to the merits of pending proceedings.

The Commission will hear additional testimony concerning UIF's quality of service at the last service hearing and the technical hearing scheduled for May 8, 2017. The Commission is scheduled to vote on UIF's quality of service, as well as the other issues raised in the rate case, on June 30, 2017. The Commission's decision must be based on evidence in the record of the case.
