PURPOSE AND EFFECT: Rule 25-22.017 would be repealed as obsolete and unnecessary to implementation of Section 120.54, F.S. Rule 25-22.039, Intervention, would be repealed and the Commission would follow Uniform Rule of Procedure Rule 28-106.205, Intervention. Rule 25-22.060 would be amended to delete paragraph (1)(e) as obsolete and unnecessary for implementation of Section 120.54, F.S.
