PURPOSE AND PROCEDURE:

The purpose of this hearing is to consider the petitions of Florida Power & Light Company and Duke Energy Florida, LLC in Docket No. 170009-EI – Nuclear Cost Recovery Clause and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the Prehearing Conference held on August 2, 2017. All witnesses shall be subject to cross-examination at the conclusion of their testimony.
