2	CHAIRMAN BROWN: With that, I would like to
3	call the meeting to order.
4	Although internal affairs is not occurring
5	today, I do want to give a shout-out to Curtis
6	Williams, who is the employee of the month. He
7	will be formally recognized at our September 7th
8	meeting. Curtis has been with the Commission for
9	30 years. And we're just grateful to have him
10	here.
11	Items 1, 3, and 4 are on the move staff list.
12	And Item 2 has been moved to the end for further
13	discussion.
14	With that, we'll get to Item 1.
15	Good morning.
16	MS. CURRY: Good morning. I'm Kiwanis Curry
17	on behalf of Commission staff.
18	Item 1 deals with the state certification for
19	high-cost support of Eligible Telecommunication
20	Carriers, or ETCs, for the 2018 calendar year.
21	Each year, carriers participating in the high-cost
22	program are required to complete Form 481 and file
23	it with the FCC and state commissions.
24	This form basically collects data regarding
25	the carrier's financial and operations information,

1	and requires the ETCs to certify that they will use
2	the high-cost support that they receive for the
3	provision, maintenance, and upgrading of facilities
4	and services for which the support is intended.
5	In order for the Florida ETCs to receive the
6	funding, the Commission must verify that the
7	carriers provided all of the required information
8	and certified to the FCC and USAC that the carriers
9	are eligible to receive high-cost support.
10	Each of the Florida ETCs has submitted their
11	Form 481 to the Commission. Staff has reviewed the
12	information and verified that all of the carriers
13	have provided the information required for high-
14	cost certification.
15	Therefore, staff is recommending that the
16	Commission certify to the FCC and USAC by letter
17	from the Chairman that the Florida ETCs are
18	eligible to receive high-cost support for the 2018
19	calendar year.
20	Staff is available for any questions.
21	CHAIRMAN BROWN: Thank you, Ms. Curry.
22	Commissioners, any comments or questions on
23	Item 1?
24	Commissioner Polmann.
25	COMMISSIONER POLMANN: Madam Chairman, I

1	reviewed this with staff. I believe this is a
