Dear Ms. Stauffer:

Virgin Mobile hereby clarifies and amends its July 18, 2017 response as follows:

Requests 3 and 9(e): During the specified period, Virgin Mobile offered its base customers a free phone plus 500 minutes and unlimited free texts each month, which they continue to receive. Beginning in December 2016, Virgin Mobile began offering new customers a free phone plus 350 minutes, unlimited texts, and 500 MB of data.

Request 11(a): Virgin Mobile has multiple toll-free numbers, which may be fewer than one hundred.

Request 11(c): Virgin Mobile no longer advertises via radio.

Request 11(e): Virgin Mobile is partnering with Medicaid providers on a national rollout, and also has partnerships with other companies that service the low income population. Virgin Mobile is also partnering with Sprint's 1M Project to provide a "graduation program" for students who lose their eligibility for the 1M Project due to high school graduation.
