CHAIRMAN BROWN: Item 2, Mr. Williams.

MR. WILLIAMS: Good morning, Chairman Brown, Commissioners. Curtis Williams with the Office of Industry Development and Market Analysis.

Item 2 addresses the selection of a new Relay service provider for the State of Florida. In Issue 1 staff recommends the selection of Sprint as the Relay service provider beginning service on March 1st, 2018. As you all are aware, at the May 4th, 2017, agenda the Commission issued a request for proposals specifically describing the Relay service to be provided.

The Commission received two proposals in response to the request for a proposal: One from Hamilton Relay and one from Sprint. Staff's recommendation to select Sprint is based on proposal, evaluation, and calculation results as part of a formal evaluation process. In Issue 2 staff recommends that the docket remain open for the life of the contract. Staff is available for questions. Thank you.

CHAIRMAN BROWN: Thank you, Mr. Williams.

Commissioner Polmann has a question.

COMMISSIONER POLMANN: Madam Chairman, I would commend staff on the -- excuse me -- the thorough analysis on this particular RFP, and I would comment

that I had an excellent briefing, answered many of my questions, and I would simply move the staff recommendation on this. CHAIRMAN BROWN: Thank you. Is there a second? COMMISSIONER BRISÉ: Second. CHAIRMAN BROWN: And I also want to commend staff for their analysis of this. Hamilton and Sprint both submitted great proposals. You know, Sprint just happened to get a higher score, but I would encourage Hamilton to stay involved in this arena as well. With that, all those in favor, say aye. (Vote taken.) All right.
