2 **CHAIRMAN BROWN:** Item 4. And I do want to
3 note, Commissioners, we do have technical staff from
4 TECO on the line, on the call here if you have any
5 questions.

6 **MS. MTENGA:** Good morning, Commissioners.
7 Moni Mtenga of Commission staff.

8 Item 4 is TECO's petition to modify -- to
9 approve modifications to its neighborhood weatherization
10 and energy education, awareness and agency outreach
11 programs.

12 The utility seeks to replace the current
13 compact florescent lamps with light emitting diode lamps
14 that are included as part of the energy efficiency kits
15 for each program. The change from CFLs to LEDs reflects
16 changing technologies and allows TECO's programs to
17 continue to advance the policy objectives of FEECA.

18 There are no customer comments received in
19 relation to this petition, and staff recommends that
20 costs associated with the modified programs be eligible
21 for cost recovery through TECO's energy conservation
22 cost recovery factor. The utility is present and is
23 available to answer questions. Staff is also available
24 to answer any questions.

25 **CHAIRMAN BROWN:** Thank you.

1 Commissioners, any questions? This is a great
2 program, and I think -- and I'm very supportive of it.

3 Commissioner Polmann.

4 **COMMISSIONER POLMANN:** Madam Chairman, I would
5 support your comments. I think, based on changing
6 technology, this is most appropriate and I would support
7 this item. If there's no further discussion, I would
8 move approval.

9 **CHAIRMAN BROWN:** Thank you.
