6 Item 9 is Gulf Power Company's petition for
7 approval of revised underground residential distribution
8 tariffs and associated charges. The URD tariffs apply
9 to new residential subdivisions and represent the
10 additional costs Gulf incurs to provide underground
11 distribution service in place of overhead service.
12 Typically the URD customer is the developer of the
13 subdivision.

14 There have been no customer contacts. Based
15 on our review of the filing and support documentation
16 provided, staff believes the proposed URD tariffs and
17 associated charges are reasonable and we recommend
18 approval.
