St. Joe Natural Gas Company, Inc. ("SJNG") by and through its undersigned officer, hereby submits its Prehearing Statements for the hearing scheduled to commence in the proceeding **October 25, 2017**.

A. Witness that may be called:

C. Statement of Basic Position:

The Commission should approve the final adjusted net true-up amount for the twelve- month period ending December 31, **2017** including interest, the projected conservation program expenses for the twelve-month period ending Dec 31, **2018** and the Conservation Cost Recovery Factors to be applied to customer bills rendered for the twelve-month period ending December 31, **2018** as filed by SJNG.

D. SJNG's position on each issue:

**Issue 1.** What are the final conservation cost recovery adjustment true-up amounts for the period January **2016** through December **2016**?

**SJNG:** An under-recovery of **\$17,951**.

**Issue 2.** What are the appropriate conservation adjustment actual/estimated true-up amounts for the period January through December **2017**?

**SJNG:** Conservation adjustment actual/estimated true-up is **\$32,966**.

**Issue 3.** What are the appropriate total conservation adjustment true-up amounts to be collected/refunded from January through December 2018?

**SJNG:** The total conservation adjustment true-up amount to be collected is **\$50,917 under-recovery**.

**Issue 4.** What are the final conservation cost recovery adjustment true-up amounts to be collected during the January through December **2018** period.

**SJNG:** The true-up amount to be collected is **\$189,567**.

**Issue 5.** What are the conservation cost recovery factors for the period January 2018 through December **2018**?

**SJNG:** The appropriate factors are:

<b>RATE CLASS</b>	<b>RATE/SPER THERM</b>
<b>RS-1</b>	<b>\$0.44277</b>
<b>RS-2</b>	<b>\$0.26916</b>
<b>RS-3</b>	<b>\$0.20359</b>
<b>GS-1</b>	<b>\$0.17729</b>
<b>GS-2</b>	<b>\$0.08111</b>
<b>GS-4/TS-4</b>	<b>\$0.03728</b>

**Issue 6.** Should the Commission approve revised tariffs reflecting the natural gas conservation cost recovery amounts and establishing natural gas conservation cost recovery factors determined to be appropriate in this proceeding?

**SJNG:** Yes. The Commission should approve revised tariffs reflecting the new Conservation Cost Recovery charges determined to be appropriate in the proceeding.

**Issue 7.** What should be the effective date of the new conservation cost recovery factors for billing purposes?

**SJNG:** The effective date should be January 1, **2018**.
