4           **MS. WU:** Good morning, Madam Chairman and  
5 Commissioners. Jenny Wu on behalf of staff.

6           Item 6 is Tampa Electric Company's petition  
7 for approval of depreciation rate for Polk 2 combined  
8 cycle generation. This item has three issues. There is  
9 no intervenor, and the staff is not aware of any public  
10 comments or concerns on this matter.

11           Polk 2 combined cycle was placed into service  
12 the beginning of this year. It is composed of a mix of  
13 existing and new assets. Staff recommends approval of a  
14 depreciation rate of 2.9 percent applicable only to the  
15 new assets.

16           Staff also recommends the effective date of  
17 the new depreciation rate as of February 1st, 2017,  
18 which is the first full month not (verbatim)  
19 depreciation expense of the asset will be calculated.  
20 Staff is available for any questions you may have.

21           **CHAIRMAN BROWN:** Thank you, Ms. Wu.

22           Commissioners, any questions on this? This  
23 seems straightforward.
