I am a senior citizen who owns my own home with my husband and we are trying to make ends meet on social security. Our water bill from Utilities Inc. in September was \$38.22 with an Avg. Daily Use of 101.79 gallons billed at an Avg. Daily Cost of \$1.37 for 28 days. We just received our October bill for \$69.05 with an Avg. Daily use of 81.03 gallons billed at an Avg. Daily Cost of \$2.38 for 29 days. That is 20.76 gallons less for \$30.83 more, nearly double the cost. This is outrageous and it is price gouging!!

It is just cruel to nearly double the rate in an area where there are many seniors trying to make it on fixed incomes. Our social security incomes will not be increasing enough to cover this and everything else that will also be increasing at the beginning of 2018. We do not make enough to pay for other peoples' salary increases, company profits, and increased pensions for Utilities, Inc. employees. We also don't use enough water to warrant being punished by doubling our rate so that we will use less. How am I supposed to use less when I am now rationing toilet flushes?

I feel that this is a tactic to run certain demographics out of Longwood, knowing that this puts a terrible hardship upon those of us who were targeted - knowing that a lot of retirees are living in these neighborhoods. Is anyone looking out for the residents here who were hit? Not only is this an unfair increase no matter how you look at it, I feel that those living on fixed incomes should be exempt. Taking from our small income to sweeten someone else's salary/pension/profits is just abhorrent!
