8 for approval of a negotiated renewable energy power  
9 purchase agreement with Bay County Florida. This  
10 contract is a continuation of two previous  
11 contracts executed between the utility and Bay  
12 County, which were approved by the Commission in  
13 2008 and 2014, respectively. Payments for energy  
14 are expected to produce net-present-value savings  
15 of approximately \$250,000 over the term of the  
16 contract.

17 Staff has reviewed the utility's petition and  
18 recommends that it is approved as filed. No  
19 comments were filed in this docket.

20 Staff and the utility are available for any  
21 questions.
