Just received my latest bill from Utilities Inc. to find that my base water charges have gone from \$4.44 a month to \$8.95 per month, a 102% increase and the charge per gallon has gone from .94 a gallon to \$1.52 per gallon per month, an increase of 62%. Rates for wastewater are similarly outrageous from \$1.88 per 1,000 gallons to \$4.05 per 1,000 gallons - an increase of 115%. I find these rates to be unacceptable, especially whenever there is a power outage as we saw during Hurricane Irma, the lift stations lose power and the sewage percolates out onto the side walks and streets.
