Hello,

I would like to voice my opinion on the ongoing issues with FPL's Turkey Point nuclear power plant.

The use of the aging cooling canals has got to stop, due to the very real threat of hypersaline leaks infiltrating the Biscayne Aquifer -- the only source of drinking water for millions of people in South Florida. FPL should immediately begin construction of a standard cooling tower -- *the same as used by every other nuclear power plant in the world* -- which will provide for much safer containment of the reactor waters. Although the costs to both clean up the cooling canals and also construct a cooling tower will be astronomical, FPL should bear the majority of those costs, given its chronic denial of problems with the leaking canals *for almost 40 years*. It is their inaction that has turned a mediocre aspect of their nuclear plant into a grave situation that imperils the health of millions of South Floridians. Therefore, **I would propose a 75/25 split between FPL and its customers** of the costs to clean up the cooling canals as well as construct a much-needed cooling tower.
