1 PROCEEDINGS 2 CHAIRMAN BROWN: Moving to Item 4, which I 3 believe has an oral modification. 4 MS. PAGE: Yes, Chairman Brown. In Item 5 No. 4, staff recommends that the Commission deny a 6 formal compliant filed by Mr. Devonson Walker, 7 concerning his electric-service account with 8 Florida Power & Light Company. 9 In Issue 1, staff recommends that the 10 Commission grant FPL's motion to dismiss in part 11 because Mr. Walker alleges a Fourth Amendment 12 violation, which is a claim not within the 13 Commission's jurisdiction. 14 Staff recommends that the Commission deny 15 FPL's motion to dismiss in part because Mr. Walker 16 alleges that he was billed and overbilled by FPL 17 for electric service; an allegation that is within 18 the Commission's jurisdiction. 19 In Issue 2, staff recommends that Mr. Walker's 20 complaint be denied because FPL properly billed 21 Mr. Walker. Staff would like to make oral 22 modifications to Issue 2 of the recommendation. 23 The oral modifications have been filed in docket --24 in the docket file for this complaint. On Page 2 of the recommendation and in 25

1 Issue 2, under staff analysis, in the fourth paragraph on Page 5, and in the conclusion on 2 3 Page 6, staff would like to replace the word "back-4 billing" with the word "billing." 5 Also, on Page 2, fifth sentence, first 6 paragraph, staff would like to add the phrase, "On 7 a reasonable estimate of the energy used." 8 In the first sentence, second paragraph on 9 Page 5, staff would like to add that FPL 10 disconnected Mr. Walker's electric service for 11 non-payment. 12 In the same paragraph, staff would like to add 13 the phrase, "Mr. Walker's premises with unmetered 14 electric service" to the beginning of the fifth 15 sentence. 16 And staff would like to add the following 17 sentence to the end of that paragraph, "At this 18 time, Mr. Walker's electric service was 19 disconnected at the pole for non-payment of energy 20 used due to unauthorized jumpers." 21 In the third sentence of the fourth paragraph 22 on Page 5 --23 CHAIRMAN BROWN: Ms. -- Ms. Page, we have 24 copies of the oral modification. Thank you. 25 MS. PAGE: Yes.

1 Commissioners, any questions CHAIRMAN BROWN: 2 on this item?
