This is to advise you that Tampa Electric Company will be filing an Amended Petition in the above docket to update the company's storm damage costs and proposed Interim Storm Cost Recovery Charges from those set forth in the its December 28, 2017 Petition in this docket. It is anticipated the Amended Petition will be filed later this week or early next week. Accordingly, we request that the Staff refrain from expending any further efforts preparing a Staff Recommendation addressing the pending Petition for the February 6, 2018 Agenda Conference and, instead, await our filing of the Amended Petition. It is our hope that the Amended Petition can be taken up at the Commission's March 1, 2018 Agenda Conference so that new tariffs can be placed in effect April 1. 2018.
