Complaint: Improper Billing against Utilities, Inc. of Florida Details:

"Utilities, Inc. Florida additional rate adjustment Docket No. 160005WS") needs to be rejected by the Florida PUC. The request was filed on November 21, 2017 and it appears that there was no formal public hearing. Utilities Inc has already indicated that this rate increase has already been approved by the Florida PUC and will be incorporated in bills being mailed after January 21, 2018 (see below)

On November 22, 2017 Utilities Inc. filed its notice of intention with the Florida Public Service Commission to increase water and wastewater rates in Charlotte, Highlands, Lake, Lee, Marion, Orange, Pasco, Pinellas, Polk, and Seminole Counties pursuant to this Statute. The filing is subject to review by the Commission Staff for accuracy and completeness. If approved by the Commission, water rates will increase by 0.59% and wastewater rates will increase by 0.88%. Additionally. Miscellaneous Service Charges will increase by 0.72%. These rates should be reflected on your bills for service rendered on or after January 21, 2018.

Furthermore it is believed that this rate increase will be approved by the PUC based upon the failure of the Florida PUC to take action when a rate increase was previously submitted for consumers obtaining their water from Sanlando PUC where data clearly showed that this utility was over performing and a rate decrease was justified in addition to the failure of the Florida PUC to reject the statement of the utilities Inc rate consultant that increasing the rates to Sanlando and reducing the water rates to the additional Florida utilities serviced by utilities Inc did not constitute a subsidy

We received another notice in January that back in November, Utilities Inc asked to increase water and wastewater rates AGAIN. This is the 2nd time in 6 months. We just had an increase take effect in August 2017. This is getting ridiculous. Our bill has nearly doubled with these increases and we are not seeing any difference in our water quality. In addition, Utilities Inc regularly sends us direct mail letting us know that they don't cover any of the pipes that could be damaged so we also have to pay a separate service for that coverage.
