Dear Mr. Hardy:

On November 13, 2017, City Communications Inc. filed an application for authority to provide telecommunications service in Florida. As you are aware, per phone conversations and the follow up email sent on November 29, 2017, staff determined that City Communications Inc.'s application is incomplete. On page 3 question 8, City Communications Inc. provided an incorrect registration number from the Florida Secretary of State. Proof of authority to operate in Florida from the Florida Secretary of State is a requirement to provide telecommunication service in Florida. Also, City Communications Inc. has not provided the information requested in Section 17 of the application which states that applicants must submit the following:

- (a) Managerial capability: resumes of employees/officers of the company that would indicate sufficient managerial experiences of each.
- (b) Technical capability: resumes of employees/officers of the company that would indicate sufficient technical experiences or indicate what company has been contracted to conduct technical maintenance.
- (c) Financial capability: applicant's audited financial statements for the most recent three (3) years. If the applicant does not have audited financial statements, it shall so be stated. Unaudited financial statements should be signed by the applicant's chief executive officer and chief financial officer affirming that the financial statements are true and correct and should include:
 1. the balance sheet,
 2. income statement, and
 3. statement of retained earnings.

Consistent with the requirements presented above, we request that City Communications Inc. submit the missing applicable information by January 4, 2017. In accordance with Section 2.07.C.5.f., of the Florida Public Service Commission Administrative Procedures Manual, if we do not receive the requested information by January 4, 2017, staff will consider City Communications Inc.'s' application incomplete and deny application.

Your company may avail itself of the statutory confidential provisions of Section 364.183, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, if it believes it is necessary to comply with this data request.

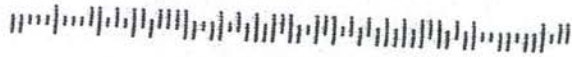
