This recommendation addresses the request for confidential classification and motion for protective order for certain information contained in responses to Citizens' 9th set of interrogatories (ROGs), No. 184 and 10th requests for production of documents (PODs), No. 147, provided in Document No. 01175-2018 by Florida City Gas (FCG), pursuant to Section 366.093 of the Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code.

Staff has reviewed FCG's responses to Citizens' ROG No. 184 and POD No. 147, which contain proprietary operational flow, cost estimates, and communications with FCG's engineering design contractor that are confidential business information and information relating to competitive interests. Disclosure of such information could impair the competitive business of the provider of information or the efforts of the public utility or its affiliates to contract for goods or services on favorable terms. In staff's opinion, the request meets the criteria for confidentiality set forth in Section 366.093(3)(d) and (e), F.S. Therefore, staff recommends that FCG's request for confidential classification be approved.
