SEMINOLE ELECTRIC COOPERATIVE'S

Seminole Electric Cooperative, Inc. ("Seminole") pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Third Request for Confidential Classification of certain information provided in its responses to Staff's First Set of Interrogatories (Nos. 1-34) and documents produced in response to Staff's First Request for Production (Nos. 1-19).

1. On January 29, 2018, Seminole responded to Staff's First Set of Interrogatories and First Request for Production of Documents. Certain confidential information (DN 00736-2018) was submitted with a Notice of Intent to Request Confidential Classification (DN 00735-2018) pursuant to Rule 25-22.006, Florida Administrative Code

2. On February 16, 2018, Seminole filed its Second Request for Confidential Classification (DN 01396-2018) seeking confidential classification for this same information (DN 01397-2018).

00736-2018 and DN 01397-2018) to Seminole on February 28, 2018. Seminole then filed a Notice of Withdrawal of its Second Request for Confidential Classification on February 28, 2018. ۰.

4. Pursuant to the discussions between counsel for Seminole and counsel for Staff, it was determined that Seminole would provide some of the returned documents to Staff without confidential classification, and that Seminole would file a new request for confidential classification for the remaining information and documents.

 Accordingly, Seminole submits this Third Request for Confidential Classification for certain information and documents provided in response to Staff's First Set of Interrogatories and First Request for Production.

6. The following exhibits are included with this request:

(a) Exhibit A is a package containing redacted versions of the documents for which Seminole requests confidential classification. The specific information for which confidential treatment is requested has been blocked out by opaque marker or other means.

(b) Exhibit B is a package containing un-redacted copies of the documents for which Seminole seeks confidential treatment. Exhibit B is being submitted separately in a sealed envelope labeled "CONFIDENTIAL." In the un-redacted version, the information asserted to be confidential is highlighted in yellow.

7. The Responses to Interrogatory Nos. 6, 18, and 33 contain information related to bids or other contractual data related to a Request for Proposal ("RFP") that Seminole issued for generating capacity. The disclosure of this information would

impair the efforts of Seminole to contract for goods or services on favorable terms. See Section 366.093(3)(d), F.S. The purpose of Seminole's RFP was to obtain potentially favorable contract terms for alternatives required to meet the reliability needs of Seminole and its Members. Without assurances that the terms of the bids received will not be publicly disclosed, potential bidders might withhold sensitive engineering, construction, cost, or other information necessary for Seminole to understand and assess the costs and benefits of their proposals. Further, without assurances of nondisclosure, potential bidders might choose not to respond to RFPs that Seminole may issue in the future. In either case, Seminole's efforts to contract for goods and services on favorable terms would be impaired by disclosure of the information deemed confidential by bidders. Accordingly, the information identified in Attachment A qualifies for confidential classification under Section 366.093(3)(d), Florida Statutes. Likewise, the information relates to competitive business interests, the disclosure of which would impair the competitive business of the bidders who provided the information to Seminole. As such, the information also qualifies for confidential classification under Section 366.093(3)(e), Florida Statutes.

8. The document titled "CONFIDENTIAL-170266-Staff's 1st POD No. 6-Rate Schedules" contains "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." §366.093(3)(e), Fla. Stat. Specifically, this information is Seminole wholesale pricing data, the release of which could impair Seminole's ability to competitively bid in the wholesale market.

The document titled "CONFIDENTIAL-170266-Staff's 1st POD Nos. 11-13 Out of Model" provides data that is confidential for the following reasons:

- a. This document contains end-user data that, if released, could "cause harm to the ratepayers." §366.093(3), Fla. Stat. This data relates to commercial and industrial load profiles, the release of which could harm the competitive interests of these end-users.
- b. This document contains information regarding confidential, ongoing negotiations with third parties regarding changes in transmission service. The disclosure of this information would impair the efforts of Seminole to contract for goods or services on favorable terms because, without assurances that terms under negotiation remain confidential, potential counterparties will be unwilling to enter into negotiations with Seminole. *See* Section 366.093(3)(d), F.S.
- 10. Accordingly, these categories of data qualify for confidential classification under §366.093(3), Florida Statutes.

11. Attachment 1 to this Request is a matrix identifying specific information within these responses and documents which are considered confidential, along with the specific statutory justification for seeking confidential classification.

12. The information for which Seminole seeks confidential treatment is intended to be and is treated as confidential by Seminole. The information has not been disclosed to the public.

13. Seminole requests that the information identified above be classified as "proprietary confidential business information" within the meaning of section 366.093(3), F.S., that the information remain confidential for a period of at least 18 months as provided in section 366.093(4), F.S., and that the information be returned as soon as it is no longer necessary for the Commission to conduct its business.

WHEREFORE, for the foregoing reasons, Seminole Electric Cooperative, Inc. respectfully requests that this Third Request for Confidential Classification be granted.
