3	MR. ELLIS: Good morning, Commissioners. Item
4	6 is Gulf's petition for approval of an
5	experiential curtailable load program. The
6	petition fulfills the requirement of the
7	stipulation and settlement agreement to resolve the
8	2016 base rate proceeding which required Gulf to
9	submit for Commission's approval a curtailable load
10	program for large customers. Eligible customers
11	can receive a monthly bill credit in exchange for
12	Gulf having the right to reduce or curtail their
13	demand during peak periods, avoiding or delaying
14	the need to construct additional power plants and
15	meeting the policy objectives of the Florida Energy
16	Efficiency and Conservation Act.
17	The program appears cost effective, produces
18	measurable savings and is monitorable. Therefore,
19	Staff recommends approval of Gulf's petition and
20	recovery through the Energy Conservation Cost
21	Recovery Clause. No customer comments were
22	received in this docket and the Staff is available
23	to answer any questions you may have.
