In 2015, the FCC approved the selection of a new vendor, iconectiv, for the nation's master local number portability system, the Number Portability Administration Center (NPAC). The system is actually a series of databases representing seven regions of the country. The newly built iconectiv system has been undergoing testing for a number of months and is due to turn up first in the Southeast region of the U.S. on April 8, 2018. On that date, carriers using the NPAC will be cut over from the current systems operated by Neustar to the new iconectiv systems. It is our understanding that there is currently no agreed upon rollback plan from the iconectiv systems back to the Neustar systems should the transition not go as planned.
